This form must be signed by each rider before the ride begins. No rider may participate without a completed form.

In consideration for being permitted to participate in the **11th Annual Molly-Dharma Run** (“the Event”) on **June 11th, 2017**, I hereby acknowledge, represent, and agree as follows:

I am physically capable of participating in the Event. I have no physical or medical condition which would endanger me or others if I participate in the Event. I certify that that any equipment I will use will be in proper working condition. I acknowledge that I am solely responsible for my personal health and safety and the personal property I bring with me. I have read the Event description and rules of participation. I will abide by all rules and regulations established by Event organizers and personnel as well as state and local vehicle codes. I agree to adhere to all other Event rules, and to conduct myself in a safe and prudent manner while participating in the Event. I agree that my continued participation throughout the Event is subject to the sole discretion of the Event organizers and volunteers and should I be requested to discontinue my participation for medical, safety or any other reason, I shall immediately end my participation and carry out such directives.

I consent to and permit emergency medical treatment in the event of illness or injury, including transportation to a medical facility, and will be responsible for any and all related costs.

I give Molly-Dharma Run, Inc. and the Event organizers permission to use my name and any photograph, voice or likeness of me during the event in any promotional materials or publications. I consent to and authorize, in advance, such use and waive my rights of privacy I have in connection therewith.

I understand that my participation in the Event is or may be dangerous and does or may involve risks of injury, loss, or damage. I further acknowledge that such risks may include but not be limited to bodily injury, death, and/or property loss or damage. I acknowledge that such risks may arise from a variety of foreseeable and unforeseeable circumstances connected the operation of motorcycles and the use of public streets, highways and roadways where significant hazards exist. I am aware of the risks that may occur. I am voluntarily participating in this event with knowledge of the dangers involved. I hereby expressly assume all such risks of injury, loss, or damage to me or to any third party arising out of or in any way related to the Event.

By signing this **RELEASE AND INDEMNIFICATION AGREEMENT**, I further hereby waive, and exempt, release, and discharge Molly-Dharma Run, Inc., its officers, employees, and volunteers, and any and all sponsoring organizations, Event organizers and promoting organizations, beneficiary(ies) of the Event proceeds, property owners, law enforcement agencies, and public entities (collectively referred to as “Releasees”), from and against any and all claims, demands, and actions for such injury, loss, or damage, arising out of or in any way related to the Event.

I further agree to defend, indemnify and hold harmless the Releasees from and against all liability, claims, and demands, including any third party claim asserted against the Releasees or any of them, on account of injury, loss, or damage, including without limitation claims arising from bodily injury, personal injury, sickness, disease, death, property loss or damage, or any other loss of any kind whatsoever, which arise out of or are in any way related to the Event.

By signing this **RELEASE AND INDEMNIFICATION AGREEMENT**, I hereby acknowledge and agree that said **AGREEMENT** extends to all acts, omissions, negligence, or other fault of the Releasees, and that said **AGREEMENT** is intended to be as broad and inclusive as is permitted by the laws of the State of Colorado. If any portion hereof is held invalid, it is further agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I understand and agree that this **RELEASE AND INDEMNIFICATION AGREEMENT** shall be governed by the laws of the State of Colorado, and that jurisdiction and venue for any suit or cause of action under this Agreement shall lie in the courts of Denver, Colorado.

This **RELEASE AND INDEMNIFICATION AGREEMENT** shall be effective as of the date set forth below and shall be binding upon me, my successors, representatives, heirs, executors, and assigns.
